Dear Parent or Guardian,

Thank you for considering St. Albert the Great School for your child(ren)'s education! Our Catholic faith is the basis for the moral formation of our students and we welcome the opportunity to affirm the God-given dignity of each student regardless of their faith background. We draw students from six different area school districts with a wide variety of faith, cultural and economic backgrounds. St. Albert is proud to be one of the only schools to offer a specialized autism program and a Gold-star rated Preschool.

Enrollment for the 2025-2026 school year has begun. Please fill out the attached registration form and return it to the school office as soon as possible to schedule admission testing. Enrollment is not complete and admission is dependent upon the results of testing and/or shadowing (for middle schoolers). Our enrollment period closes on July 1, 2025.

Tuition for the 2025-2026 school year for K-8 remains at \$6,500 per student. Each family will receive a \$344.00 StAG discount, so total tuition due per student is \$6,166.00. There are several options for families to receive tuition assistance. Families can apply for the Ohio EdChoice Scholarships with awards ranging from \$61.66 to \$6,166 per student. Families can also apply for Catholic Education Foundation (CEF) Grants and/or limited scholarships through St. Albert the Great Parish. Both the CEF grants and parish scholarships can be applied for through the FACTS Tuition Management system. Families must apply for EdChoice first in order to be considered for parish scholarships. The deadline to apply for CEF and parish scholarships is February 24, 2025. Families who are awarded the CEF or parish scholarships will be notified before the end of the current school year.

The registration fee (non-refundable) is \$150.00 and is due with the registration paperwork. This year we are adding a \$200 technology fee per family which is due by 6/1/25. This fee will allow us to refresh our chromebooks and other technology on a consistent schedule to ensure our students have reliable, up-to-date technology to assist their education.

All new families will be invited to create an online account with FACTS Tuition Management System and enroll in AutoPay for incidental billing. This will require families to provide a payment method (either bank account or credit card) to FACTS. Your enrollment will not be

<u>complete or guaranteed until this step is done.</u> If you have questions or concerns about this you may contact Ann McManus in the Business Office at (937) 293-1191 to discuss.
